ORDER

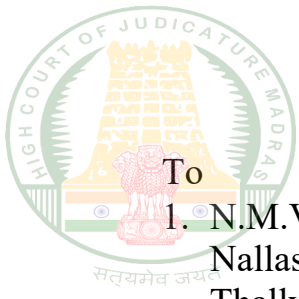
This Civil Miscellaneous Petition is filed to condone the delay of 221 days in representation of S.A.SR.No.98308 of 2025 on the file of this Court.
