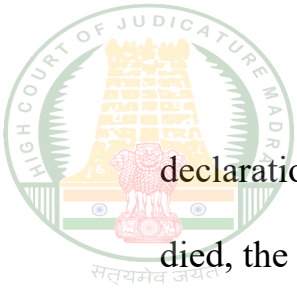

ORDER

Challenging the impugned order passed in IA.No.3 of 2024 in OS.No.12 of 2024 on the file of District Munsif, Uthukkottai, the revision petitioners / plaintiffs have preferred this revision.

2. The learned counsel for the revision petitioner submitted that the second respondent died in Ireland and the petitioner was unable to obtain the death certificate due to permit restrictions in the said country. However, the revision petitioner has taken steps to implead the legal heirs of the second defendant, but the same was not accepted by the trial Court. The suit is one for



declaration and other consequential reliefs, and if the second defendant has died, the legal heirs are necessary parties to the proceedings.
