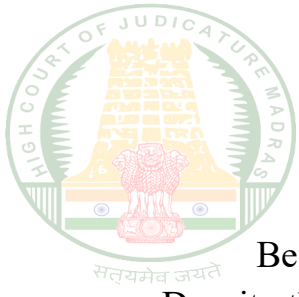

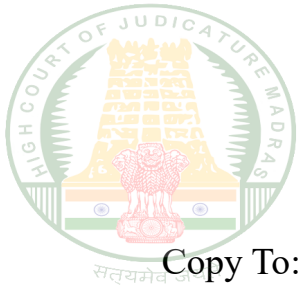
## **ORDER**
