The earlier order granting interim stay is extended till the disposal of the writ petition.

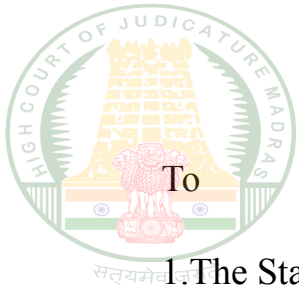
