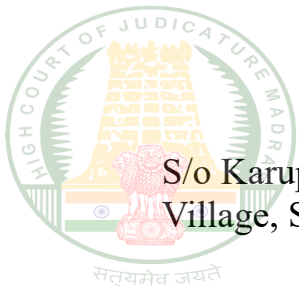

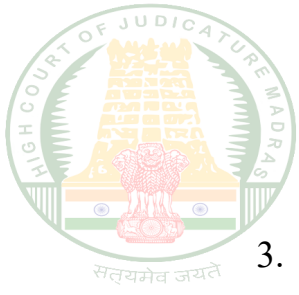

ORDER

The petitioner herein filed IA.No.405 & 406 of 2024 in OS.No.41 of 2018 on the file of the Additional District Judge, Kallakurichi, seeking to amend the plaint and to reopen the case on the side of the plaintiffs. Upon hearing both sides, the Trial Court dismissed the applications. Challenging the same, the petitioners filed these petitions.

2. The learned counsel for the petitioners submit that though there were sufficient pleadings with regard to alleged document, but the petitioners have not sought relief of declaration by oversight. Hence, the petitioners filed the petition to amend the plaint and to reopen the case on the side of the plaintiffs. However, the Trial Court declined to give the said relief. If the opportunity is not given to the petitioners, their valuable right will be defeated. Hence, he prays to allow these petitions.



3. Admit. Issue notice to the respondents returnable by 21.04.2026.

Private notice is also permitted. Post the matter on 21.04.2026, till then, the Additional District Judge, Kallakurichi, is directed not to proceed with OS.No.41 of 2018.
