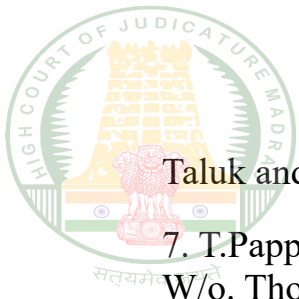

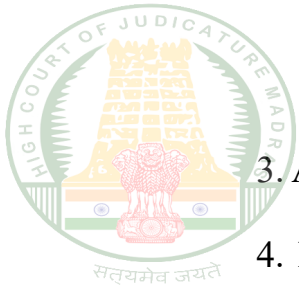

ORDER

Challenging the impugned order passed by the trial Judge in I.A. No.1 of 2025 in O.S.No.20 of 2025, the defendant has preferred this revision.

2. The learned counsel for the revision petitioners submits that before the trial Court, an application was filed under Section 8 of the Arbitration and Conciliation Act, 1996, to refer the matter to arbitration, as there is already a Clause 13 in the agreement between the parties. As per Clause 13 of the agreement, if any dispute arises between the parties, the same has to be referred to an Arbitrator, with the Arbitrator to be appointed in the manner specified therein. However, the Court below failed to take note of this clause and erroneously dismissed the application. Therefore, the order requires interference. The reasons assigned are justifiable.



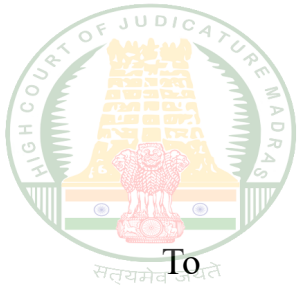
3. Admit. Issue notice to the respondent, returnable by 23.06.2026.
