4. The Draft Rules have been received by this Court.

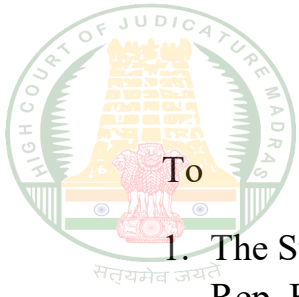
