3. The 3rd respondent is directed to furnish all the aforesaid particulars with relevant documents on the next hearing date.

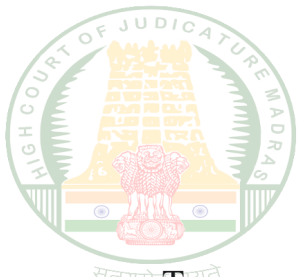
