ORDER

This Writ Petition has been filed challenging the impugned refusal check slip dated 24.12.2025 issued by the 2nd respondent refusing to register the Family Settlement Deed presented by the petitioner for registration stating that the settlor shall specify the property as founded in O.S.No.273 of 2019 alone and re-present the document for registration.

2. Mr.U.Baranidharan, learned Special Government Pleader, accepts notice on behalf of the respondents.

3. The petitioner has challenged the impugned refusal check slip on the ground of violation of the principles of natural justice, and on the ground that it is a non-speaking order. The petitioner also categorically contends that the executant of the document presented for registration is legally empowered to execute the said document.

4. As seen from the impugned refusal check slip, the petitioner was not afforded of any opportunity of hearing prior to the passing of the impugned order. Neither the petitioner's contentions nor the supporting documents produced by him were considered in the impugned order.

Being a non-speaking order with regard to the petitioner's contentions and the supporting documents produced by him, and an order passed in violation of the principles of natural justice, this Court is of the considered view that the impugned refusal check slip dated 24.12.2025 issued by the 2nd respondent has to be quashed and the matter has to be remanded back to the 2nd respondent for fresh consideration on merits and in accordance with law.

5. Accordingly, this Court is inclined to dispose of this writ petition in the following manner:-

(a) The impugned refusal check slip dated 24.12.2025 is quashed by this Court and the matter is remanded back to the 2nd respondent for fresh consideration on merits and in accordance with law.

(b) The petitioner shall submit a written explanation to the 2nd respondent within a period of two (2) weeks from the date of receipt of a copy of this order, as to why the 2nd respondent has to accept the registration of the Family Settlement deed presented by the petitioner for registration, along with supporting documents.

(c) On receipt of the same within the time stipulated, the 2nd respondent, after giving due

consideration to the written explanation submitted by the petitioner along with supporting documents, shall take a final decision with regard to registration of the Family Settlement Deed presented by the petitioner, on merits and in accordance with law, within a period of six weeks thereafter.

(d) If the 2nd respondent decides to refuse to register the Family Settlement Deed, the 2nd respondent shall pass a speaking order, after giving due consideration to the contentions of the petitioner and the supporting documents produced by him.

6. In the above terms, this Writ Petition is disposed of. No costs.
