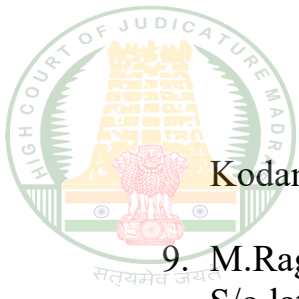

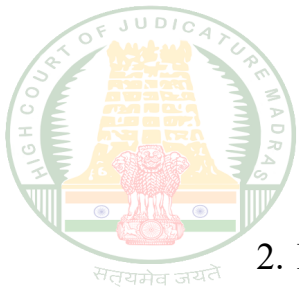

ORDER

It is submitted that the legal heirs of the deceased first respondent had taken out an application to implead themselves as legal heirs of the deceased first respondent in the Appeal filed by the first respondent in A.S.No.464 of 2010 which is pending on the file of the Additional City Civil Court-IV, Chennai.



2. From the records, it is noticed that the first respondent had refused to receive the notice in the present Revision. When steps have also been taken to implead the legal heirs of the first respondent, they were also brought on record as the notice that had been attempted to be served upon him has been returned as they are absent in the premises and the service upon them has been completed by substituted service.

3. In such an event, the learned counsel for the petitioner is directed to take steps to serve the respondents 5 to 11. On a Batta Memo being filed by the learned counsel for the petitioner, the Registry is directed to take steps to serve notice on respondents 5 to 11 through the Additional City Civil Court-IV, Chennai in the pending Appeal A.S.No.464 of 2010 which shall be served by the first Appellate Court on the next date of hearing fixed by it and such service of notice shall be reported to this Court on 09.04.2026.
