Prayer in WP.No.7459 of 2024 : Writ Petition filed under Art.226 of the Constitution of India praying for issuance of Writ of Certiorari to call for the records of the Principal Labour Court, Coimbatore in I.D. No. 34 of 2015 and quash its award dated 05.09.2023.

Prayer in W.P.No.22928 of 2025 : Writ Petition filed under Art.226 of the Constitution of India praying for issuance of Writ of Certiorarified Mandamus after calling for the records pertaining to the preliminary award dated 11.11.2020 and the final award dated 05.09.2023 passed by the Principal Labour Court, Coimbatore in ID No.34 of 2015, quash the preliminary order and the final award in so far as not granting the full back wages and other benefits from the date of dismissal to the date of death of the husband of the 1st petitioner and for a direction to the respondent Management to pay the petitioner's full back wages and other attendant benefits for the period from the date of dismissal to the date of death of the husband of the 1st petitioner and also to pay all other terminal benefits by treating as if he was continued in service till his death, after adjusting the amounts already ordered to be paid to the petitioners as compensation, award costs.
