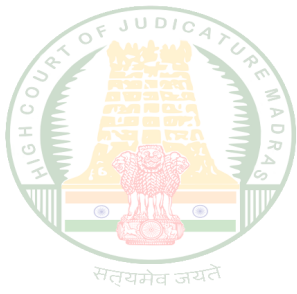

the Hon'ble Chief Justice)

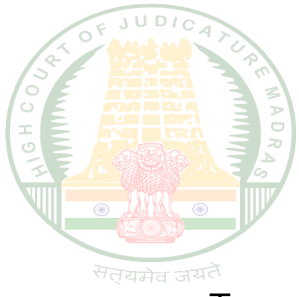
Learned counsel for petitioner seeks leave to withdraw the writ petition with liberty to challenge the order dated 24.12.2025 in a separate writ petition.

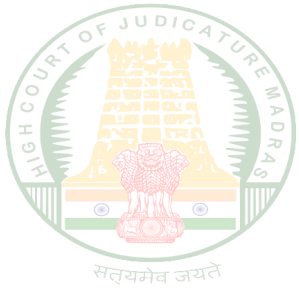
