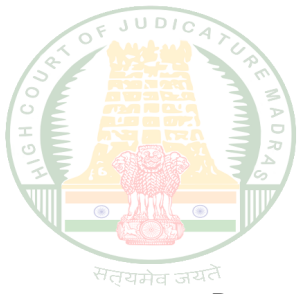

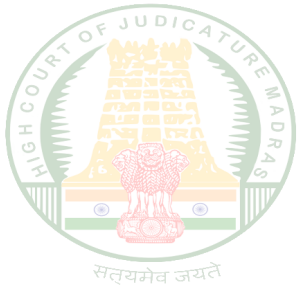

The present writ petition is filed, under Article 226 of the Constitution of India, seeking direction to the 1st respondent to consider and take necessary action on the petitioner's representation dated 04.8.2025.

2. The allegation of petitioner is that third respondent has put up unauthorised construction adjacent to his property, that too, without any building plan and planning permit issued by the competent authority.

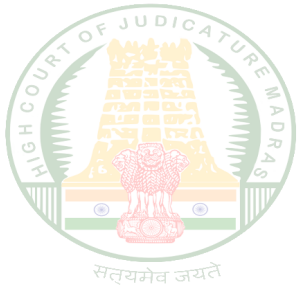
