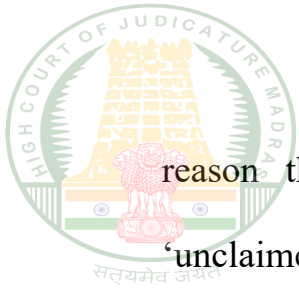

ORDER

The 1st respondent herein filed IA No.126 of 2023 in OS No.21 of 2023 on the file of the District Munsif Cum Judicial Magistrate, Kurinjpadi, under Order 3 Rule 2 CPC, to permit him to conduct the suit on behalf of 2nd respondent in pursuance of General power of attorney vide document No. 40 of 2022 registered on 05.01.2022. Upon hearing both sides, the Trial Court allowed the petition. Challenging the same, the petitioner filed this Civil Revision Petition.

2. The learned counsel for the petitioner submits that alleged power of attorney relied on by the 1st respondent is not specifically given to him to conduct the case. Furthermore, it was given much earlier in the year 2022 prior to filing of the suit and also the power of attorney is not acceptable one for the



reason that the summon issued to the 2nd respondent was returned as 'unclaimed'. Therefore, there is serious suspicious regarding availability of 2nd respondent. Hence, he prays to admit this petition.

3. Issue notice to the respondents returnable by 22.04.2026. Private notice is also permitted. Post the matter on 22.04.2026, till then, the District Munsif Cum Judicial Magistrate, Kurinjipadi, is directed not to proceed with OS No. 21 of 2023.
