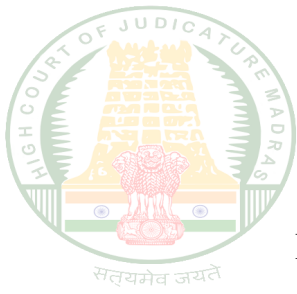

ORDER

(Order of the Court was made by P.Velmurugan J.)

Mr.U.Karunakaran, learned counsel appeared for the sole respondent.

2. Since the petitioner/appellant had been enjoying the benefit of an order of interim injunction from the inception of the suit till its disposal, the petitioner/appellant is entitled to get same benefit. On a perusal of the affidavit reveals that the appellant has made out a *prima facie* case and that balance of convenience is in favour of the appellant. If the interim injunction is not granted, the appellant would be put to irreparable loss and injuries. Hence, there shall be an order of interim injunction for a period of four weeks.

3. Post the matter after four weeks.
