The petitioner herein filed IA.No.4 of 2024 in HMOP.No.208 of 2022 on the file of the Family Judge, Salem, seeking to direct the respondent to pay a sum of Rs.2,00,000/- per month as interim maintenance to the petitioner and child and Rs.50,000/- for litigation expenses. Upon hearing both sides, the Trial Court directed the respondent to pay a sum of Rs.30,000/- per month as interim maintenance. Challenging the same, the petitioner filed this Civil Revision Petition.

2. The learned counsel for the petitioner submits that the respondent is earning Rs.3,00,000/- per month and the petitioner is living with special child who requires medical treatment. But considering the above fact, the Trial Court fixed Rs.30,000/- as interim maintenance. Hence, the petitioner filed this Civil Revision Petition for enhancement.

3. Admit. Issue notice to the respondent returnable by 22.04.2026. Private notice is also permitted. On receiving notice, the respondent is directed to deposit arrears of maintenance.

4. Post the matter on 22.04.2026.
