SOLEMNLY AFFIRMED :

Q: Is it correct to state that you have stated Ex.P2 as a legal notice but you  
have not annexed any postal slip for sending the same?

A:Yes.

Q:(Affidavit in A.No.489 of 2024 in GWOP No.445 of 2021 is shown to the  
witness) Is it correct to state that this application is only limited to the  
events occurred after the joint compromise memo?

A:Yes.

Q:I put it to you that you have enlarged your case by adding extra facts in your proof affidavit which is not feasible?

A:I deny.

Q:(Proof affidavit is shown to the witness) I put it to you that you have not filed any documentary proof to support the incidents occurred between the period 2011 and 2012 as mentioned from Para 4 to 10 of your proof affidavit?

A:I deny.

Q:(A screenshot of facebook post of the handle Hannah Dhanraj is shown to the witness )Is this the post, posted on your wall?

A:I do not remember and I cannot confirm immediately.

Q:Do you know the people Sumitha Rani and Damodharan Kuttiappan who liked your post?

A:Yes, they are my facebook friends.

Q:Is it correct to state that on 27.12.2018 you have edited a post and re-posted it in your handle as per the document filed by you?

A:I cannot confirm this.

Q:When did you come to know about the publication of the article in Ex.P3?

A:On that day itself i.e. 27.12.2018.

Q:When did you came to know about the alleged bipolar disorder undergone by the respondent?

A:December 2013.

Q:Is it correct to state that you and your husband resided together from 2013 to 2018 until the publication of the aforesaid post?

A:No. I separated from him between December 2013 and April 2014 because of physical abuse.

Q:Despite of the said condition you stayed with him from 2014 to 2018?

A:Yes. Because he assured me that he will not repeat the abuse.

Q:Have you filed any complaint over the particular abuse?

A:No.

Q:I put it to you that all your allegations are only an afterthought and it could not sustain.

A:I deny.

Q:I put it to you that you have sent mails dated 26.09.2017 and 12.04.2017 addressed by you to the respondent.

A:I deny.

Q:I put it to you that your aforesaid both e-mails contains about your shortcomings and your inability to co-operate with the family.

A:I deny.

Q:I put it to you that even before the marriage you know about the condition of respondent's depressive status alleged by you as bipolar disorder?

A:I deny.

Q:Have you both visited the doctor before your marriage for his mental disorder as alleged by you?

A:I do not remember. Witness adds:We only visited the doctor to invite for our wedding and not for his mental disorder.

Q:(A photograph is shown to the witness) It is the photograph of your marriage. Can you identify the speaker on the dais?

A:It is Dr.Rudhran, renowned Psychiatrist. Ex.R2 is the original marriage photograph of the petitioner with the respondent along with a compact disc. Ex.R3 is the certificate under 63 (4) (C) of BSA for electronic document.

Q:I put it to you that a renowned Psychiatrist cannot be a guest of the patient who is suffering from bipolar disorder as alleged by you and hence everything that you have stated is only for the sake of this case?

A:I deny.
