2. This court, by order dated 28.04.2025, passed the following orders:

“3. Interim stay till 10.06.2025 on condition that the petitioner deposits Rs.50,000/- [Rupees Fifty Thousand only] to the credit of O.S.No.1795 of 2017 on or before 05.06.2025. In the event of failure to make deposit, the interim stay granted will stand automatically vacated.

4. The learned counsel for the petitioner is also directed to take notice and permitted to serve notice on the counsel appeared for the respondent/decree holder before the execution court.”

3. Today, when the matter is taken up for hearing, the learned counsel for the petitioner submitted that the revision petitioner has deposited a sum of Rs.50,000/- as directed by this court to the credit of the original suit. He has also produced a photocopy of Demand Draft vide DD No.384291 dated 28.05.2025 drawn on Bank of Baroda, Chennai 600 001. The said statement is recorded.

4. Post this matter on 09.07.2025. The respondent(s) are permitted to
