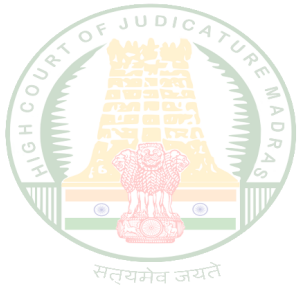

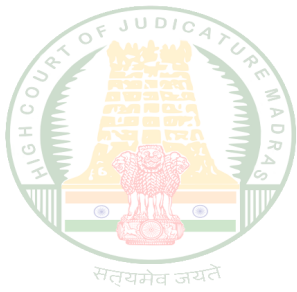

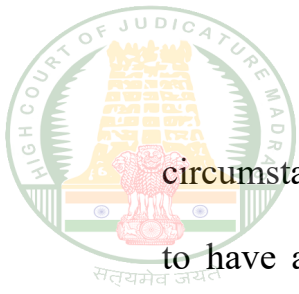

ORDER

Challenging the order dated 12.02.2026 made in I.A. No.2 of 2024 in O.S. No.93 of 2026 passed by the learned IInd Additional District Judge, Tindivanam, this Civil Revision Petition has been filed.

2. The learned counsel for the petitioner would submit that the defendants have already submitted the Original Will dated 23.03.2005 which is said to have been executed by one Saroja Ammal by filing the Written Statement. However, the Trial Court found that the said Will was not produced. Under such



circumstances, without production of the said Will, the Court below ought not to have allowed the additional Written Statement. Hence, this Civil Revision Petition.

3. Admit. Issue notice to the respondent returnable by 20.04.2026.

4. Having considered the facts and circumstances of the case and submissions made by the learned counsel for the petitioner, there shall be an order of interim stay till the next hearing.
