Directing the 1st respondent herein to initiate action on the petitioners representation dated 16.06.2025, restraining the flow of seepage, sullage and drainage water into the petitioners property bearing survey No.159/11 and also prevent the excess fresh water flowing from lake bund channels into the petitioners property by giving effect to the Judgment and Decree dated 09.04.2025 passed by the District Munsif Court, Sriperumpudur in O.S.No.4 of 2023 and also seek for compensation for the loss of potency of property since the cultivable land became uncultivable land by inaction of the 4th respondent herein, within a time frame as may be stipulated by this Hon'ble Court may deem fit.

Order

This writ petition has been filed to direct the first respondent to prevent the flow of seepage, sullage and drainage water into the petitioner's property, morefully disclosed in the prayer to this writ petition, by giving effect to the Judgment and Decree dated 09.04.2025 passed by the District Munsif Court, Sriperumpudur in O.S.No.4 of 2023.

2.The petitioner seeks compensation for the same in his representation dated 16.06.2025. According to the petitioner, the drainage water is flowing through the petitioner's property on account of the inaction of the respondents. The petitioner is also having the benefit of judgment and decree dated 09.04.2025 passed in his favour by the District Munsif Court, Sriperumpudur in O.S. No.4 of 2023, which proves that the petitioner is the owner of the property, morefully disclosed in the prayer to this writ petition. The petitioner has also filed photographs of the subject property along with this writ petition to substantiate his case that the drainage water is flowing through the petitioner's property. The petitioner had given a representation on 16.06.2025 to the first



respondent for the aforesaid purpose. Since the same has not been considered, the petitioner has filed this writ petition.

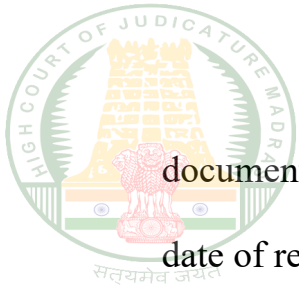

documents produced by the petitioner, within a period of 12 weeks from the date of receipt of a copy of this order. No costs.
