The learned counsel for the respondent, State are directed to file counter affidavits in all the Writ Petitions on or before 07.08.2026. In case the State is not filing counter or adopting a counter in any of the Writ Petitions, they shall file a memo to that effect. The other respondents who have got themselves impleaded have submitted that the affidavit filed in support of the respective implead petitions will be the counter.

2. Post the matter on 10.08.2026 at 02.15 p.m. for arguments. The advance copy of the counter shall be provided to all the counsels by the respondents.

3. With reference to the extension of interim orders already granted by this Court, there was a strong objection by Mr.Giridharan, stating that interim orders cannot be extended indefinitely. However, this Court finds that a Writ Petitions has been filed in WP.No.47446 of 2026 where challenge has been



made to the earlier notification in GO.Ms.No.556, Home (Police III) Department dated 01.11.2025. in and by which the respondent State has passed the following directions:-

“I. The Chairman, Tamil Nadu Uniformed Services Recruitment Board is directed to recast all gradation list issued from the year 1995 in respect of direct recruitment which includes 20% in-service candidates recruited directly to the post of Sub-Inspector of Police for granting seniority on the basis of marks obtained in the qualifying examination / selection process and to send the same to the Director General of Police / Head of Police Force, Tamil Nadu as expeditiously as possible.

ii. On receipt of the revised mark list received from the Chairman, Tamil Nadu Uniformed Services Recruitment Board, the Director General of Police / Head of Police Force is directed to take necessary immediate action to implement the orders of Supreme Court of India dated 01.05.2025 and to issue the revised seniority list of all the Sub-Inspectors of Police from the year 1995 as ordered by the Hon'ble Supreme Court of India and communicate the same to all offices concerned;

iii. The Director General of Police / Head of Police Force is further directed to send necessary amendment proposals to amend the relevant Service Rules separately within a month regarding fixation of seniority of directly recruited Sub-Inspectors of Police based on selection marks instead of Police Training Marks;



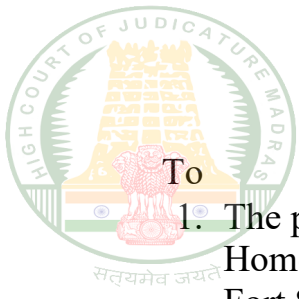
iv. *The Director General of Police/ Head of Police Force is also directed to send necessary proposal for creation of supernumerary posts, if required, at the appropriate time, on the need basis, to avoid service disruption while revising the seniority and to accommodate affected candidates as ordered by the Hon'ble Supreme Court of India.*”

4. It is after the filing of this Writ Petition that the panel which is the subject matter of challenge in WP.No.10338 of 2026 has been filed stating that the dicta laid down by the Hon'ble Supreme Court in the case of **Ranjit Singh** has not been followed while fixing the seniority panel. In this background if the panel is given effect to it would only lead to multiplicity of proceedings which is the reason why this Court initially granted the interim order. Since there has been no change in the circumstances and the State is yet to file counter and many candidates have filed implead petitions not extending the stay would cause prejudice to the petitioners and other candidates.

5. Therefore, the interim order already granted by this Court is extended till 10.08.2026.

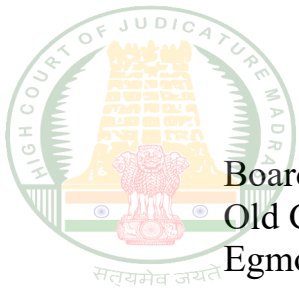

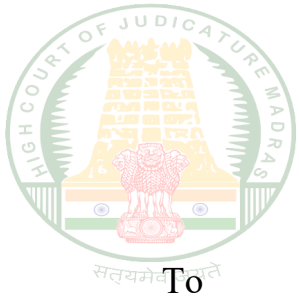

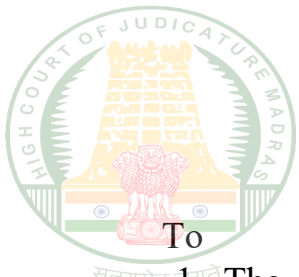
