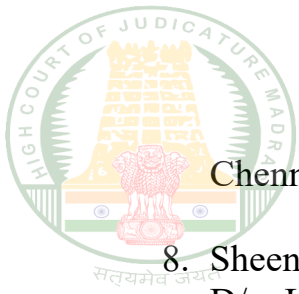

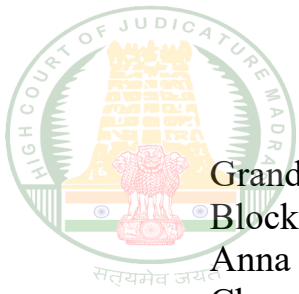

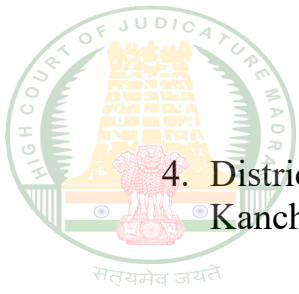

2.The learned counsel for the petitioner submitted that in similar matters in CRP.Nos.4270, 4272/2025 ; CRP.Nos.4655, 4656 & 4660/2025 ;



CRP.No.2319/2026 ; and CRP.Nos.2455, 2425, 2421, 2419, 2424, 2422/2026, this Court, vide orders dated 08.09.2025, 24.09.2025 ; 21.04.2026 and 21.04.2026, had granted interim stay. The learned counsel therefore prayed that interim stay may also be granted in the present cases.

3.It is seen that this Court, vide orders dated 08.09.2025, 24.09.2025 and 21.04.2026, in CRP.Nos.4270, 4272/2025 ; CRP.Nos.4655, 4656 & 4660/2025 ; CRP.No.2319/2026 ; and CRP.Nos.2455, 2425, 2421, 2419, 2424, 2422/2026, granted interim stay, which matters are connected to the present Civil Revision Petitions.

4.Hence, *there shall be an order of interim stay in the present Civil Revision Petitions also, till 15.06.2026.*
