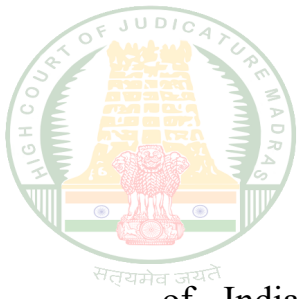

Mr.K.V.Babu, learned counsel accepting notice on behalf of the respondent, submitted that he undertakes to file vakalat before the Registry.

2.The learned counsel for the respondent also produced the Daily Status of the proceedings in EP.No.1/2022 and submitted that the delivery was effected, recorded and the EP was closed as early as on 06.04.2026 and therefore, nothing survives for adjudication in the Civil Revision Petition.
