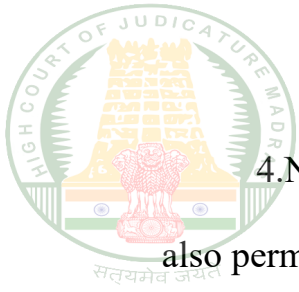
ORDER

This Writ Petition has been filed challenging the impugned order dated 27.02.2026 passed by the 1st respondent under Section 23 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007, cancelling the settlement deeds dated 15.03.2010 standing in the name of the petitioner. The petitioner has challenged the impugned order on the ground that by total non-application of mind to the fact that there is no condition imposed in the settlement deeds dated 15.03.2010 requiring the petitioner to maintain the 4th respondent, the 1st respondent has passed the impugned order. This Court has also perused and examined the settlement deeds which have not been ordered to be cancelled.

2. On a prima-facie consideration, this Court finds that there is no condition imposed in the said settlement deeds that the petitioner will have to maintain the 4th respondent. Since a *prima-facie* case has been made out by the petitioner, there shall be an order of interim stay of the operation of the impugned order dated 27.02.2026 passed by the 1st respondent.

3. Mr. N. Naveen, learned Government Advocate, takes notice on behalf of the respondents 1 to 3.
