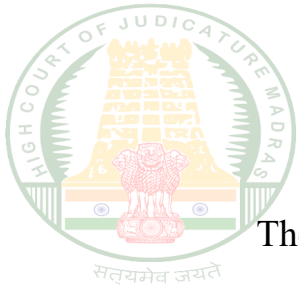

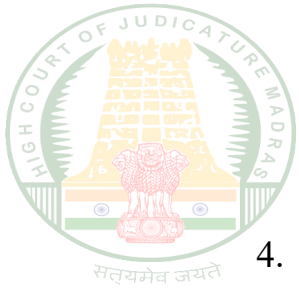

**ORDER**

The present Writ Petition has been filed seeking a direction to the Respondents 1 to 2 herein to extend the tenure of the Adhoc Committee to Manage the Muslim Masjid Wakf situated at Thiruchengode Town and Taluk, Namakkal District, to conduct, filing the cases and to remove the encroachers from the Muslim Masjid Wakf's Properties by considering the petitioner's representation dated 04.03.2026 within a time frame as stipulated by this Court.

2. Mr.M.Fakkir Mohideen, learned standing counsel takes notice on behalf of the Respondents 1 & 2.

3. Learned counsel appearing for the petitioner submitted that the petitioner being the member of the Adhoc Committee constituted by the Tamil Nadu Wakf Board to manage the affairs of the Muslim Masjid Wakf situated at Tiruchengode Town & Taluk, Namakal District and its properties for the relevant period, after the expiry of the said tenure of the Adhoc Committee, had submitted a representation dated 04.03.2026 seeking extension of the tenure and also for removal of encroachers from the Muslim Masjid Wakf's Properties. Since, no action was taken on the said representation, the petitioner has come up with the present Writ Petition.

4. Learned Standing Counsel appearing for the respondents submitted during the pendency of the petitioner's representation, an order had been passed by the respondents taking over the management of the said Masjid under the direct control of the Tamil Nadu Wakf Board and therefore, nothing survives for further adjudication in this matter.

5. Recording the said submission, the Writ Petition stands closed with liberty to the petitioner to work out the remedy in the manner known to law. There shall be no order as to costs.
