Despite time having been given to the learned counsel for the petitioner, supporting documents have not been produced to establish the fact that the appointment which was in question with regard to the teaching staff had been made prior to the appointment of the Interim Administrator, who is none other than the former Judge of this Court by judgment dated 31.07.2018.

2. Since it has been observed by the learned Writ Court in the order which is impugned herein that the appointments have been made only during the tenure of the Interim Administrator ie., between 31.07.2018 and 30.10.2022, the same cannot be questioned by the subsequent person in charge of the administration as claimed by the present petitioner as the President of Ambur Synod (IELC).
