Order : This petition coming on this day for hearing upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.L.DHAMODARAN, Advocate for the Petitioner and of MR.C.JAYAPRAKASH, GOVERNMENT ADVOCATE on behalf of the Respondents, the court made the following order:-

Mr.C.Jaya Prakash, learned Government Advocate takes notice for Respondents 1 to 3. Notice to the other respondents returnable by 13.06.2022. Private notice is also permitted.

2. The petitioner alleges that in respect of execution of registration documents, impersonation has been committed.

3. Therefore, there shall be an order of interim injunction as prayed for, till 21.06.2022.
