ORDER

On 10.03.2026, when the matter was takenup for hearing, learned counsel appearing for the appellant committed himself to pay 50% (Rs.5,00,000/-) of the principle amount of Rs.10,00,000/- as a condition for grant of interim stay.

Today, when the matter is takenup for hearing, the learned counsel appearing for the appellant produced a Demand Draft drawn in the name of the respondent, bearing D.D.No.153214828, dated 13.03.2026, on Indian Overseas Bank. The learned counsel further submits that he would hand over the aforesaid Demand Draft to the learned counsel appearing for the respondent in person.

5. Records are already before this Court, and therefore both the learned counsels consent to conduct the main appeal on 21.04.2026.
