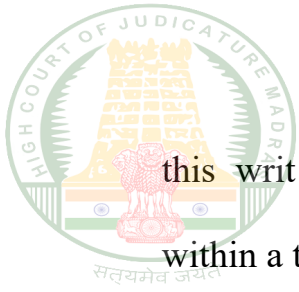

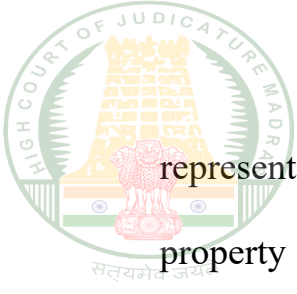

3. Mr. S.Arumugam, learned Government Advocate accepts notice on behalf of the respondent.

4. No prejudice would be caused to the respondent if the petitioner's representation, seeking for transfer of patta in favour of the petitioner for the property morefully described in the prayer to this writ petition, is considered on merits and in accordance with law after giving due consideration to the documents filed by the petitioner within a time frame to be fixed by this Court.

5. This Court is not expressing any opinion on the merits of the petitioner's representation dated 03.01.2025.

6. For the foregoing reasons, this Court directs the respondent to pass final orders on merits and in accordance with law on the petitioner's



representation dated 03.01.2025, seeking for transfer of patta in his name for the property morefully described in the prayer to this writ petition within a period of twelve weeks from the date of receipt of a copy of this order after hearing the objections of the neighbouring land owners if any and any other third party whom the respondent deems it fit to enquire.
