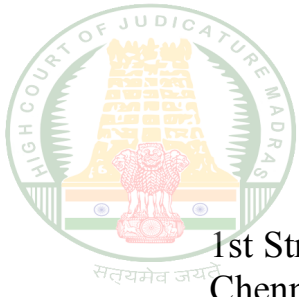

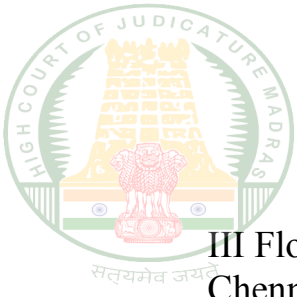

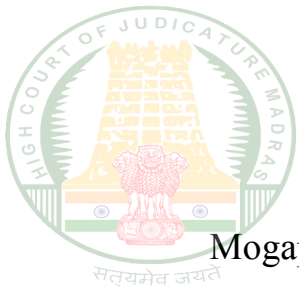

Written statement is not filed by the eighth defendant. The eighth defendant is set ex-parte. Additional written statement of other defendants are also not filed.

2. Heard both sides. Based on the pleadings in the plaint and the written statement filed by the defendants, except the eighth defendant, the following issues are framed:

i. Whether the plaintiffs are entitled to the relief sought for framing of scheme for the proper conduct of the affairs of the first defendant /Trust?

ii. Whether the second defendant is liable to be removed from the post of Trustee of the first defendant Trust?

iii. Whether the defendants are liable to render the accounts as sought for in the plaint in respect of the first defendant /Trust from the year 2016 till the actual date of rendition of accounts?



iv. *Whether the plaintiffs are entitled for permanent injunction as sought for?*

v. *Whether the plaintiffs are entitled for costs?*

vi. *What other relief the plaintiffs are entitled?*
