Solemnly affirmed:

Q49:Do you remember that there was case filed against the 1st defendant trust of your representation against the the 3rd property of the trust i.e in Ambattur and do you remember what was a result of it.

A:I do not remember.

Q50:I am saying you are deliberately suppressing the fact that the original suit No.14/2012 was filed in which you have filed an affidavit and written statements. Is it correct or not?

A:Yes.

Q51:can you tell the outcome of the case?

A: Somebody moved for seeking injunction.

Q52:What was the response or affidavit filed by you in that case for the 1st defendant trust?

A: I do not remember.

Q53:(Copy of the judgment in OS.14/2012 is shown to the witness)If I show the judgment of the case can you tell me what was your case affidavit?

A: I do not remember.

Q54:(copy of Judgment OS.14/2012 is shown to the witness) Kindly see the 3rd page of 3rd line it in the above judgment it is your statements of 1st defendant that 3rd property Ambattur is owned by the 1st defendant trust as you represented lessee as in OS.No.14/2012, before DM, Ambattur?

A: Yes it is mentioned above. The above said para 3 in 3rd page 3rd line. **(It is Marked as Ex.D1)**

Q55:From all these, it is admitted that 3rd property ambattur is owned by the 1st defendant trust. Is it correct?

A:I deny.

Q56:As you are denying can you explain/justify about the title of 1st defendant trust with respect to 3rd property at ambattur?

A: Ambattur property was purchased by Sathrasala Venkatachellum chetty during his life time in public auction held by Tahsilar in 1936 before formation of this 1st defendant Trust.

Q57:If this being true who is the present owner of the property?

A: Estate of Venkatachellum chetty.

Q58:If that being the case who is at present managing the Sathrasala Venkatachellum Estate?

A: Lakshmi Devi.

Q59:Is she alive now?

A: Yes.

Q60:will you be able to produce those documents proving the title possession of Lakshmi devi with respect to 3rd property ambattur.

A:I have to check.

Q61:When the matter with respect to the Ambattur property was raised before this Hon'ble Court during the enquiry of the pending applications No.1080,1081/2019 have you raised this issue before this Court? (Counsel for plaintiff objected for suit is pending)

A:I have no idea.

Q62:Do you know that application filed by you 1080,1081/2019 and 533/2021 were dismissed by this Hon'ble Court?

A:I do not remember.

Q63:You filed two application 1080 and 1081/2019 while filing this suit. Do you know the prayers sought by you?

A:I do not remember.

Q64:Have you preferred any appeal against those OA.1081 and 1080/2019?

A:I am not aware.

Q65:Even though you know the facts you are deliberately suppressing the facts about the proceeding of the suit?

A:I deny.
