Heard Mr.V.Manohar, learned counsel for the petitioners/tenants and Mr.N.R.R.Arun Natarajan, learned counsel for the respondents/landlords.

2. Subsequent to the proposals which were mooted by the Court and also agreed upon by the parties, the petitioners/tenants have filed individual affidavit of undertaking to vacate the respective portions under their occupation within a period of one month from the respondent in RCOP No.1548 of 2015 delivering vacant possession to the landlord.

3. The said affidavit is recorded. It is made clear that till such time, the petitioners/tenants shall pay the agreed rent without any default and shall also without seeking any further extension of time and also inducting third parties into the petition premises, they shall surrender the vacant possession to the



respondents/landlords as undertaken in Paragraph No.3 of the affidavit.
