Considering the facts and circumstances of the case, this Court without going into the merits of the case directs the respondents to consider the representations of the petitioner dated 17.11.2025, 12.01.2026, 04.02.2026 & 06.03.2026 and pass appropriate order on merits and in accordance with law within a period of six weeks from the date of receipt of a copy of this Order.

5. Accordingly, this writ petition stands disposed of. No costs.

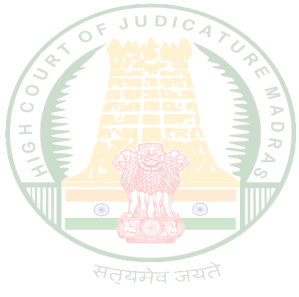
