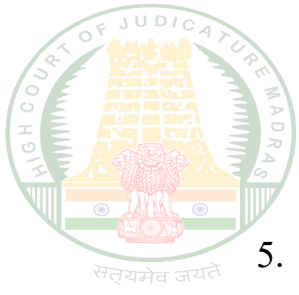
COMMON ORDER

4. Heard the learned Government Advocate appearing on behalf of the appellant.



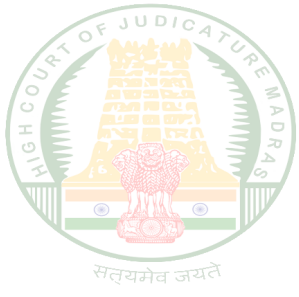
5. Considering the averments made in the affidavit filed in support of these petitions and being satisfied with the same, these Miscellaneous Petitions are ordered as prayed for.
