Learned counsel for the petitioner seeks leave of this Court to withdraw this writ petition, with liberty to approach the competent authority seeking redressal of the grievances.

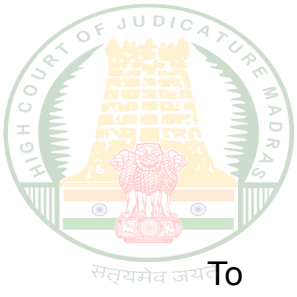
Petition is, accordingly, dismissed as withdrawn, with the aforesaid liberty. There shall be no order as to costs.

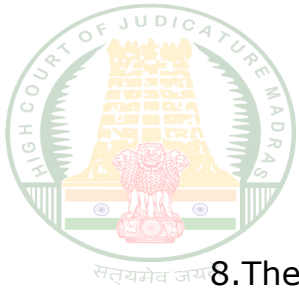
