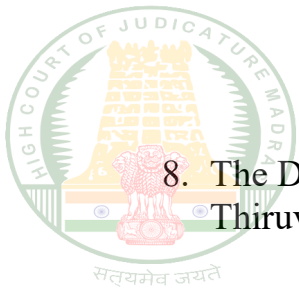

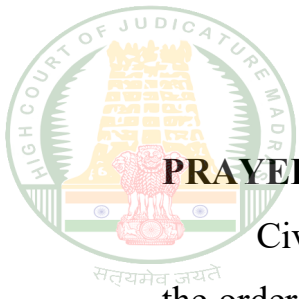

2. Considering their request, post the matter on 24.04.2026. Interim order of stay already granted by this court on 11.07.2025 is extended till then.

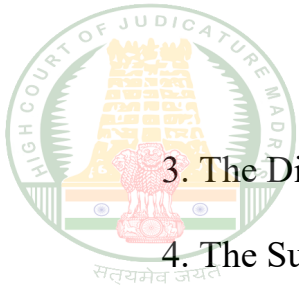
