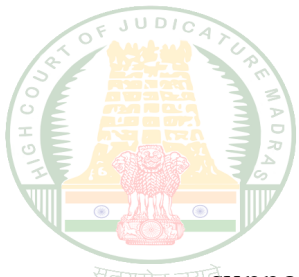

No prejudice would be caused to the respondents, if the petitioner's representation as stated supra is considered on merits and in accordance with law, after hearing the objections of the respondents 4 to 6 and any other party, whom the 2nd respondent deems it fit to enquire, within a time frame to be fixed by this Court. This Court is not expressing any opinion on the merits of the petitioner's representation, dated 14.03.2026.

For the foregoing reasons, this Writ Petition is disposed of by directing the 2nd respondent to pass final orders on merits and in accordance with law, on the petitioner's representation, dated 14.03.2026 seeking cancellation of pattas standing in the name of the respondents 4 to 6 in respect of the property morefully disclosed in the affidavit filed in support of this writ petition, after giving due consideration to the
