disclosed in the prayer to this Writ Petition, within a time frame to be fixed by this Court.

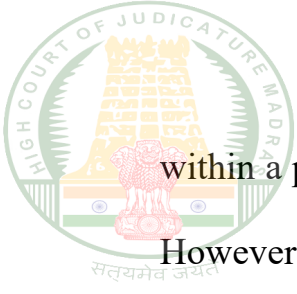

within a period of twelve weeks from the date of receipt of a copy of this order.
