Civil Revision Petition filed under Art. 227 of Constitution of India, praying to strike off the Plaint in OS No.294 of 2025 on the file of Additional District Court at Krishnagiri as re-litigation abuse of process of law and against public policy.

PRAYER IN CMP No. 10683 of 2026

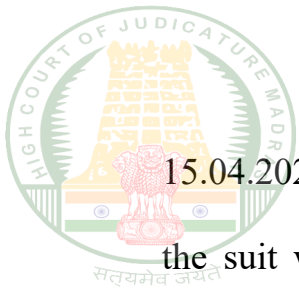

ORDER

To strike off the suit in O.S.No.294 of 2025 initiated by the respondents/plaintiffs 1 to 3 on the file of Additional District court, Krishnagiri, the revision petitioner/7th defendant had preferred this Civil Revision Petition.

2. The learned counsel for Revision Petitioner/7th defendant would submit that the impugned suit filed by the respondents/plaintiffs 1 to 3 is a clear abuse of process of law and they have deliberately suppressed the order dated

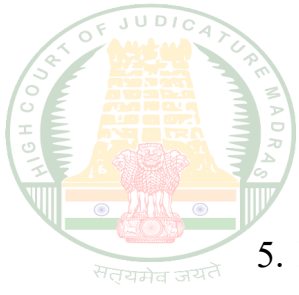


15.04.2025 passed by this Court in W.P.Nos.11825 and 13083 of 2024 and filed the suit with unclean hands. He would further submit that the reliefs in the impugned suit plaint is not maintainable as it runs contrary to the orders of this court in C.R.P.No.4050 of 2024 dated 02.12.2024 and the common order passed in W.P.Nos.11825 and 13083 of 2024 dated 15.04.2025. He would submit that the relief of declaration of title of plaintiffs on the basis of the document No.56 of 2023 and 57 of 2023 is not maintainable in law as the said documents have been declared to be non-est in the eye of law and cancelled by the order of this court in W.P.Nos.11825 and 13083 of 2024 vide directions in para 15 (d) and (e) in the said order. He would also submit that the plaintiffs claim right through Ranjithkumar, the 9th defendant and all of them were parties to the Writ Petition in W.P.Nos.11825 and 13083 of 2024 and the 2nd plaintiff along with Ranjithkumar were parties to C.R.P.No.4050 of 2024 and as such, they are bound by the said orders of this court and since the said orders were not challenged, it has attained finality. Hence, he prayed to strike off the plaint filed by the respondents/plaintiffs 1 to 3.

3. Record perused. Admit.

4. Issue notice to the respondents through court returnable by 14.07.2026.

Private notice is also permitted.



5. Post the matter on 14.07.2026. Until then, all further proceedings in O.S.No.294 of 2025 on the file of Additional District Court, Krishnagiri is ordered to be stayed.
