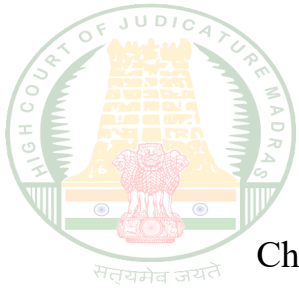

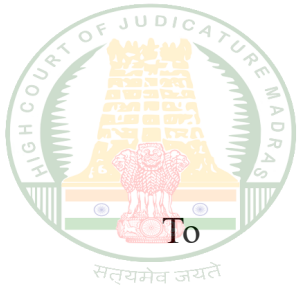
**ORDER**

Challenging the impugned order passed in I.A.No.1 of 2024 in Arb.O.P.No.5 of 2024 dated 03.03.2026, this civil revision petition is filed by the revision petitioner/Claimant.

2. Before the trial court, the revision petitioner/claimant wanted to file additional documents for fixation of fair compensation, which was denied. With regard to the land acquisition proceedings, the claimant wanted to mark the additional documents before fixing the compensation and deciding other issues. For this purpose, the claimant wants to show the nature of the property and the value of the property before the adjudicating authority and it would not cause any prejudice. But the trial Judge erroneously dismissed the said I.A. In view of the fact that the Land Acquisition Act is a beneficial legislation, I.A.No.1 of 2024 is allowed. The findings of the learned District Judge, Tirupattur, dated 03.03.2026 passed in I.A.No.1 of 202 in Arb.O.P.No.5 of 2024 is set aside. Accordingly, this civil revision petition is allowed. No costs. Consequently, connected Miscellaneous Petition is dismissed.
