4. List before Joint Registrar (Appellate Side) on 27.06.2025 to enable writ petitioner to effect service on R11.

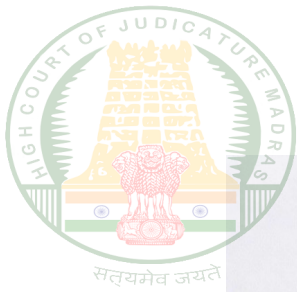

6. Let Joint Registrar (Appellate Side) make a PBC (Post Before Court) order after service is duly effected on R11. If this exercise is not completed, let Joint Registrar (Appellate Side) put up a suitable note.'

2. Today also, position *qua* service on R11 is no different. In other words, even as on date, R11 remains unserved which is evident from the scanned reproduction of today's cause list reflecting the captioned matter.

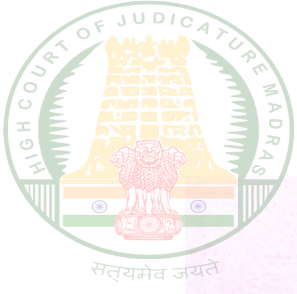

It is most respectfully submitted that pursuant to the direction of the Hon'ble Division Bench of this Court dated 20.06.2025, the matter was listed before the Joint Registrar (AS) on 27.06.2025 for effecting service on the unserved R11.

2. It is submitted that when the matter was listed on 27.06.2025, the learned counsel for the petitioner was present and sought time to file a writ regarding R11, and the matter was adjourned to next week. When the matter was listed on 04.07.2025, the counsel for the petitioner was present and he stated that he filed a writ with petition regarding R11 on 04.07.2025, vide SR.No.20183/2025. Office was directed to verify and put up to issue notice to R11, and the matter was adjourned to next week. 5. To enable writ petitioner to effect service on R11, who remains unserved, by resorting to substituted service, list this matter before Joint Registrar (AS) on 08.08.2025.

6. Let the exercise before Joint Registrar (AS) be completed in four weeks therefrom i.e., by 05.09.2025.

7. If R11 is duly served within aforementioned time frame, Joint Registrar (AS) to make a PBC (Post Before Court) order, otherwise put up a suitable note.
