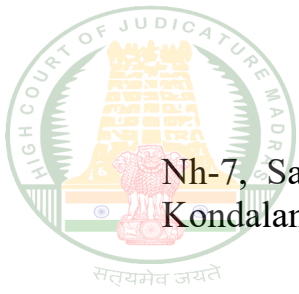

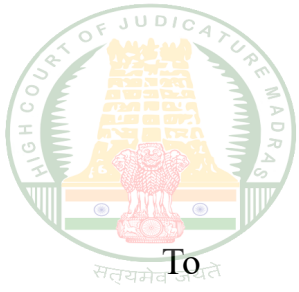
appointed by the Mediation Centre on or before 29.04.2026 and the matter shall be mediated. The Mediation Centre will fix a day and send notice to both the side.
