ORDER

2. Mr.D.Ravichander, learned Special Government Pleader, accepts notice on behalf of the respondent 1 to 4.

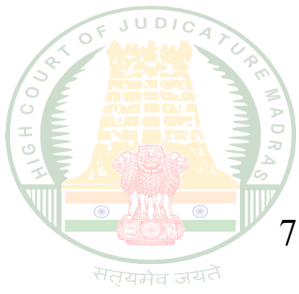

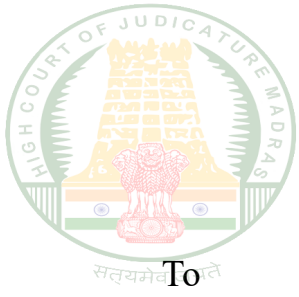
