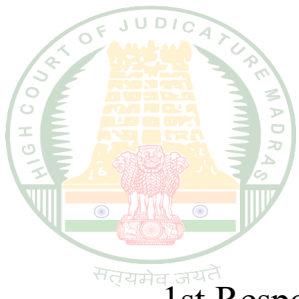

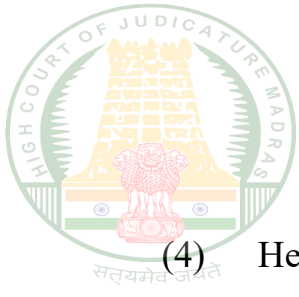

- (2) Notice to the 4th respondent through Court as well as privately returnable in eight weeks.
- (3) The order of the State Human Rights Commission dated 10.12.2025 made in SHRC.No.4682/2020, is under challenge in the present writ petition. Earlier, when the very same order of the State Human Rights Commission, which is impugned in the present writ petition, came up for consideration before this Court, being satisfied that the recommendations of the State Human Rights Commission, *prima facie*, not sustainable, has granted an order of interim stay of recovery proceedings and the departmental action contemplated as against the petitioner therein.
