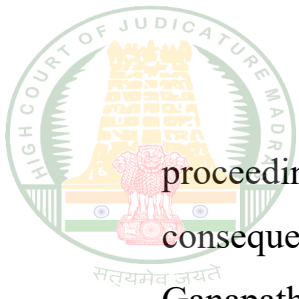

6.For the foregoing reasons, this writ petition is disposed of by directing the second respondent to pass final orders, on merits and in accordance with law on the petitioner's appeal dated 27.12.2025, after hearing the objections of respondents 4 to 10 and by adhering to the principles of natural justice, within a period of 12 weeks from the date of receipt of a copy of this order. No costs.
