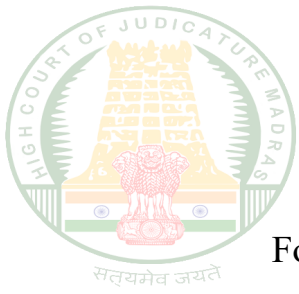

Mr. M.R.Gokul Krishnan, learned Additional Government Pleader, takes notice for the first respondent.

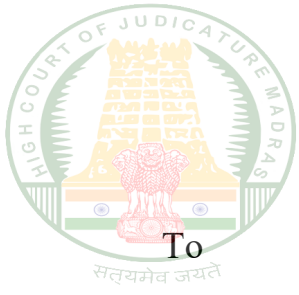
2. Notice to the respondents 2 to 4 returnable by 09.07.2026. Private notice is also permitted.
