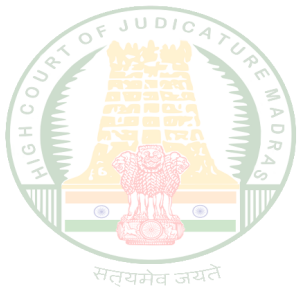

5. With the aforesaid direction, this Writ Petition is disposed of.

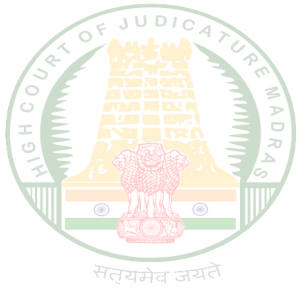
