ORDER

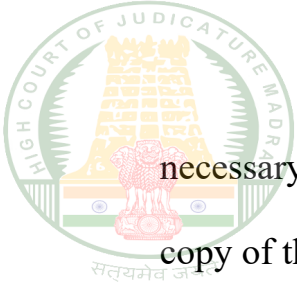

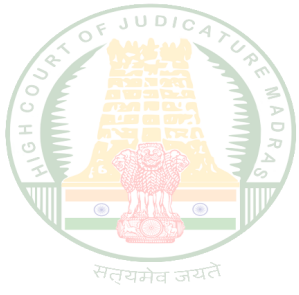
