Challenging the rejection of the docket order passed by the trial Court on the memo filed by the revision petitioner/wife in O.P. No. 4126 of 2024 dated 12.03.2026, the present Civil Revision Petition has been filed.

2. The learned counsel for the petitioner would submit that the petitioner had filed a memo dated 12.03.2026 in OP.No.4126 of 2024 before the trial Court seeking rejection of the divorce petition filed by the respondent/husband on the ground that there are substantial arrears of maintenance payable by him, despite directions issued by this Court in earlier C.R.P. proceedings. It is contended that the said directions have not been complied with.

3. It is further submitted that the trial Court, without properly considering the said aspect, rejected the memo on the ground that the order passed by this Court is under review. According to the learned counsel, even otherwise, in

view of the admitted arrears of maintenance, the respondent ought not to be permitted to prosecute the proceedings without complying with the earlier directions. Prima facie, the said contention requires consideration.

2. Admit. Notice.

3. Issue notice to the respondent, returnable by 29.06.2026.

4. In the meantime, there shall be an order of interim stay of the operation of the docket order dated 12.03.2026 passed in O.P. No. 4126 of 2024.

5. Post the matter on 29.06.2026.
