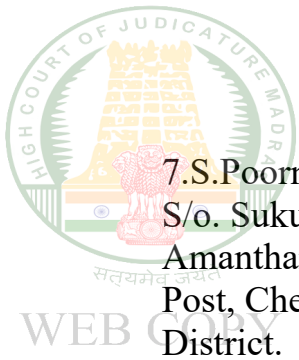

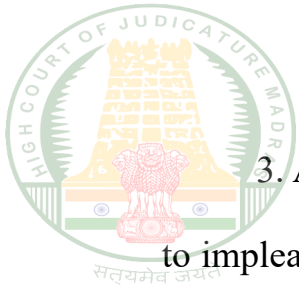

ORDER

Aggrieved by the order passed by the learned trial Judge in I.A. No. 5 of 2025 in O.S.No.16 of 2012, the proposed ninth defendant has preferred this revision.

2. Before the trial court, he filed an application seeking to implead himself as the ninth defendant, stating that the suit properties were purchased by his father and that the patta stands in his father's name. Ever since the purchase, the petitioner's father has been in possession and enjoyment of the property. He further stated that the petitioner's father had earlier filed a suit in O.S. No. 317 of 1991, which was dismissed. Against the said dismissal, an appeal was filed in 2006, numbered as A.S. No. 15 of 2006, which is still pending.



3. As the present suit also involves the same property, the petitioner seeks to implead himself as a party. However, his application was dismissed. The trial court failed to properly appreciate the facts and circumstances of the case.

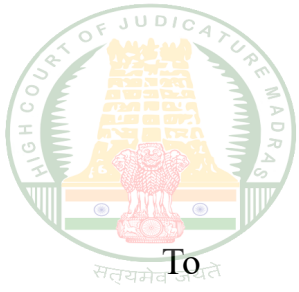
4. Admit. Issue notice to the respondents, returnable by 06.07.2026.
